

Privacy Policy

At Wiman Corporation, your privacy is of utmost importance to us. We do not sell information that we gather to any company, organization, or person outside of our organization.

Information Collection

Wiman Corporation is the sole owner of the information collected on this web site. Wiman Corporation collects information from our users at several different points on our web site. The information (name, company name, address, phone number, email address) entered by individuals or businesses that request product information or technical assistance on our site is maintained in our server database. The email addresses of those who subscribe are stored in a database that is used only to communicate new products, learning opportunities such as webinars and workshops and information on our products.

To serve you faster and with better quality, we use “cookies” technology. Cookies are small text files, usually stored on a user’s computer hard drive, which enable a web site to “personalize” itself for each user. We use cookies to store visitors preferences, record session information, record user-specific information on what pages users access or visit, alert visitors to new areas that we think might be of interest to them when they return to our site, record past activity at a site in order to provide better service, customize web page content based on visitors’ browser type or other information that the visitor sends. No third party has access to the information we collect this way, but if you’d rather we didn’t use cookies when you visit us, you can set your browser not to accept cookies. If you do disable cookies in your browser, you may not be able to take advantage of certain personalized features enjoyed by other visitors to our web site.

Personally Identifiable Information

Security

Information transmissions over the Internet cannot be 100% secure.
